THE BASICS

Refining Professionalism: Think and communicate as a professional, value collaboration and diversity, and behave ethically.

Improve Critical Thinking: In this course, you will be asked to connect ideas from classroom lectures and discussions and apply them in practical situations in the lab. You will also be asked to evaluate information logically to solve problems and find solutions.

Practice Effective Communication: In this course, you will be expected to actively listen to others (or carefully read others' discussion board posts) including other students, guest speakers, and the instructor. You will also share your ideas and thoughts through interactions. In some cases, that will be a written product (essay, research paper, etc.) or through an oral presentation (speech, demonstration, lecture). Effective communication also includes timely conversations with instructors and responding to emails.

Participate Collaboratively: In this course, you will be asked to contribute as a team member for certain projects, while working with others in the lab, and in interactions with community members. You might not always agree with other members' perspectives, but you are expected to acknowledge them and respect the diversity of ideas that are shared.

Act Ethically: In this course, you are expected to behave in a way that demonstrates honesty, equity, empathy, and trust. For example, you are responsible for your own work. Students that plagiarize will be referred to administration. Following all safety rules and procedures, without taking shortcuts, demonstrates ethical behavior to follow rules. Treating all others respectfully demonstrates equity. This class will follow the School District of Fort Atkinson's guidelines in regards to academic dishonesty:

Cheating

Cheating will NOT be tolerated!

- Anyone caught cheating will be subject to the disciplinary actions set in the student handbook.
- In addition, anyone caught cheating will receive a zero for the assignment.

Live Responsibly: Adapt to change, respect yourself and all others, value the environment, and accept ownership of your actions.

Develop Resilience: Things happen. Especially things that you might not anticipate or for which you are unprepared. When things happen, please know that you can reach out to me! As the instructor, I will work with you to help you overcome these disruptions, be able to make some accommodations in the classroom or connect you with others that can also help.

Foster Accountability: Accountability is taking ownership of your choices but also following through on your commitments. In this course, you can demonstrate accountability by turning in assignments on time, collaborating with your peers on group projects, attending class sessions regularly, and redoing assignments based on feedback. You are taking ownership of your success in this course by asking questions, participating in class, and engaging in the course materials.

Cultivate Passion: Find your purpose by being curious, practicing self-reflection, and genuinely connecting with others.

Expand a Growth Mindset: Working to correct mistakes, developing a deeper understanding, and applying instructors feedback to course products demonstrates a growth mindset. In this course, I welcome you to fix your mistakes when the opportunity arises. That means that you can retake a test, correct an assignment, or resubmit a project for additional points if you have taken the steps necessary to demonstrate improvement in your understanding.

Enhance Personal Connections: Remember that everyone is coming to class with something on their minds. Interact with each other in a way that demonstrates kindness and concern for their well-being. Respect their boundaries and their perspectives.

FFA

- All students will automatically become FFA members. The National FFA Organization is dedicated to making a
 positive difference in the lives of students by developing their potential for premier leadership, personal
 growth and career success through agricultural education.
- The Fort Atkinson FFA has an active chapter that offers members numerous opportunities to develop leadership and communication skills, form lasting friendships, and learn those skills needed in the job market.
 - In order to provide more members with these opportunities, the Fort Atkinson FFA will pay the state and national dues for all students enrolled in an agriculture culture. Opportunities to accumulate points will be shared in class, and members can see an advisor anytime to find out more information on accumulating points and the events going on.

Technology:

Please make sure that you **bring your Chromebook (or personal computer)** and charger to each class as we will be using them most days. Various other types of technology will be utilized throughout your agriculture course. You are expected to use the items properly and carefully, following all instructions.

CELL PHONES - Will follow the guidelines set forth in the Fort Atkinson High School Student Handbook Stated as follows:

"Use of electronic devices during the school day causes significant disruption to the learning environments and/or severe distraction to individual learners. Since FAHS students are issued a chromebook, personal electronic devices should remain off and out of sight unless expressly given permission by the classroom teacher. Definition of electronic devices include but are not limited to: cell phones, tablets, personal computers, earbuds/airpods, headphones, smart watches, cameras. Use of electronic devices is prohibited during class time, unless an extreme exception has been made by the classroom teacher and administration due to the unique need in a particular class.

Students shall be permitted to use electronic devices on school premises and at school-sponsored activities under the following conditions:

- Student use of electronic devices is permitted before 7:50am and after 3:10 pm (or after 1:30 pm on Early Release Days) unless otherwise noted.
- Students may also use electronic devices during passing times between classes and during lunch periods.

In addition,

- Electronic devices may not be used during assemblies and/or presentations.
- The use of electronic devices to take photographs or to receive or transport video images is strictly prohibited at all times in locker rooms, restrooms and other similar private areas.
- It is prohibited to take photographs and/or to receive or transport pictures or video images, with

intent to embarrass, harm or demean another student or staff member, without the consent of the

individual being captured. Students who use an electronic device in violation of this policy shall be subject to disciplinary action in accordance with established district and school procedures.

Classrooms will have one of two options for electronic device storage while in class: Safely stored in a designated pocket chart or safely stored in a basket. Students are to adhere to the classroom guidelines established by each teacher for use of electronic devices.

Students not in compliance with the electronic device policy will experience the following:

- **First violation**: A reminder given to the student to put the electronic device in the proper classroom safe storage. Refusal to comply or a repeated pattern of violation will lead directly to step 3.
- Second violation: The student will be requested to turn the electronic device into the classroom

teacher for the remainder of the period. Refusal to comply or a repeated pattern of violation will lead directly to step 3.

- Third violation: The student will be removed from class to speak with administration.
- **a.** If the electronic device is becoming a habitual/repeated issue, administration will connect with the family to devise a better plan for the device (ie. turning electronic device into the main office at the beginning of each school day and/or parent/guardian managing device during school hours)
- **b.** Repeat violations of electronic device use could lead to, but is not limited to detention, athletic code violations, and exclusion from outside activities that may include field trips and school-sponsored events."

EARBUDS/HEADPHONES/ETC - Earbuds/headphones/etc should NOT be in your ears/on your head while the teacher is teaching or classmates are presenting. Use of them during work time is at the discretion of the teacher, however using such devices connected to a cell phone is strictly prohibited due to the outlined policy above.

CREDIT HOUR GUIDELINES

All Western courses follow the Department of Education's Federal definition of credit hour. Typically, students enrolled in a one-credit course should plan to spend approximately 5 to 6 hours per week (in a 7-week course) attending class, completing assignments, doing homework, etc. This calculation is scaled up as the number of credits increase.
